1 Unfair Dismissal bot

Assists in determining if an employee can bring an unfair dismissal claim.

2 Independent Contractor Agreement bot

A tool to generate an independent contractor agreement to engage another person or business to provide services.

3 Continuing Legal Education bot

Records continuing legal education details and maintains a record.

4 Consultancy Agreement Generator

A bot that generates consultancy agreements.

A tool to identify legal risks facing a small business.

6 Diversity and Inclusion Maturity bot

Bot that creates a D&I benchmark so you can measure future progress.

7 KYC (know your client) bot

An information gathering tool to onboard new clients.

8 Costs Agreement bot

A bot that generates a costs agreement between the law firm and the client.

9 Engagement Letter bot

A bot that generates an engagement letter for new client work.

10 Concierge bot

A bot that acts as the concierge for a law firm's intranet, pointing people to the right places and people.

11 Statement of Claim bot

A bot that generates the Statement of Claim (Particulars of Claim) and additional claim forms needed to file a matter with the courts or arbitration tribunal

12 Cease and desist letter bot

Generates cease and desist letters ready to be sent to the opposing party.

13 Deed of release bot

A tool that helps users generate a Deed of release (to resolve a dispute).

14 Letter of demand bot

A tool used to generate letters of demand to send to debtors.

15 Application of GST/VAT bot

Considers whether GST/VAT applies to a specific transaction.

16 Award Application Guidance bot

Helps assess whether an employee is covered by an award (which regulates pay rates and conditions of employment) and if so, what award is applicable.

17 Business Health Check

A tool to identify legal risks facing a small business.

18 Case Management Track Assistance bot

Helps assess which case management track a dispute before the courts will be assigned to.

Consultancy Agreement Generator

A bot that generates consultancy agreements.

Estate Planning bot

A tool that assesses a client's estate planning needs and makes recommendations for next steps.

Franchise Documentation bot

Tool that generates a suite of franchise documentation, such as Franchise Agreement, Disclosure Document, and Information statement.

Immigration Documentation bot

A tool that generates immigration forms, such as the I-485 form.

23 IP Assignment Agreement bot

Generates an IP assignment agreement.

24 Lease Agreement bot

Generates a lease agreement.

25 Loan Agreement bot

Generates a loan agreement.

26 Master Lease Generator

A self-service tool for generating leases.

27 Memorandum of Understanding bot

A bot that automates the production of a memorandum of understanding.

28 Power of Attorney

A self-service tool for generating a Power of Attorney.

29 Restrictive Covenants bot

A bot that determines the laws in relation to restrictive covenants in a given jurisdiction.

30 Series A Termsheet

Self service bot for a Series A term sheet.

31 Shareholders Agreement bot

Self-service document automation tool that generates a shareholders agreement.

32 Subscription Agreement bot

Generates an agreement for the purchase of shares from a company.

33 Tenancy Agreement bot

A tool that generates a residential tenancy agreement.

34 Term Sheet for Investment

A tool to create a term sheet for investment in a business.

Term Sheet for a Sale of Business

A tool to create a Term Sheet for the sale and purchase of all the assets in a business.

36

Terms of Trade bot

A tool to record the essential terms and conditions on which a business will supply goods and/or services.

37

Website Privacy policy bot

A tool to generate a Website Privacy Policy that sets out the rules and processes a business must follow when dealing with its customers' personal information.

Website terms and conditions

A tool to generate the Website Terms and Conditions on which a business allows people to access and use the business website.

39 Financial Services Assessment bot

A bot that provides advice in relation to whether a particular organization requires a financial services license or not.

40 Force Majeure assessment bot

A bot that considers whether the force majeure clause in a contract is applicable

41 Immigration status assessment bot

A tool that considers the immigration status of an individual.

42 Legal Professional Privilege

Advises if legal professional privilege applies in a situation.

43 Litigate v settle assessment

A tool that helps a disputes team assess if they should advise their client to litigate or settle.

44 Long service leave guidance bot

Generate advice in relation to where a particular employee is entitled to long-service leave.

45 Stamp Duty Calculator bot

A bot that assesses the rate of stamp duty applicable in the sale of land.

46 Superannuation Entitlement bot

Determines whether or not particular employees are entitled to superannuation and what kind.

47 Tax Disclosure Assessment bot

A bot that assesses whether an individual needs to disclose their tax exposure to the relevant tax authority.

48 Tax Obligations assessment bot

A tool that assesses what tax obligations an individual has as an employee vs contractor.

49 Visa Type Assessment bot

A bot which determines what type of visa a person should be on in a particular jurisdiction.

50 Whistleblower advice bot

Determines whether a particular situation or disclosure is subject to a whistleblowing regulatory scheme.
